Outreach ADHOC committee:

The outreach committee would like to thank all the groups in the GPA for welcoming this committee into their business meetings. Overall the greetings we received where warm, and welcoming. When we began this ADHOC committee the number of groups attending the ASC regularly on average was 14, now at the end of this ADHOC committee there is an average of 22 meetings represented at the ASC meeting regularly. The information gathered was that groups that do not attend Area Service on a regular basis are groups that are lacking support and members willing to be active. Some feedback we received from groups is as follows; the ASC meeting is to long, the ASC meeting is chaotic, and frustrating, and hard to follow. Individual feedback was that addicts did feel welcomed at Area and felt lost during the process of doing business. They also stated they did not feel welcomed or encouraged to ask questions. It appears that after the Outreach presentation that included what the ASC is for and what is does, groups have responded positively by now sending a GSR. A suggestion from this ADHOC is to continue to have a position that welcomes newer groups and GSR's and checks in with groups regularly for feedback. This could be accomplished by either making the Outreach Committee a standing Sub-committee or once a year appointing an ADHOC to visit groups that are struggling with attendance at the ASC meeting. In closing the committee would like to state that this was an incredible learning experience and gave the committee members a chance to visit other groups in our Area that they may not have attended in the past.
