Report from Regional Weekend: RCM Report Greater Providence Area

I was in attendance for our Regional Weekend held in Brocton Ma. 12/13/08 Regional Sub-Committees from 12:00 to 4:15 12/14/08 Regional Service Committee 11:30 to 6:15 There was good attendance for the Regional Sub-Committees. On Sunday after Regional Sub-committee Chairs Reports, and Area Reports and Lunch Break... We moved into Old Business... Finance Motion was passed...GPA voted no per conscience from our November ASC. On to New Business... Money Motions were as follows... \$1,100.00 for new computer......Vote Results: NO \$140.00 RD & RDA attendance North-East Zonal Forum to be held in Cromwell Ct...... Vote Results: Yes \$\$1,400.00 RD & RDA attendance at World wide Workshop in Oakland Ca.... Wote Results: Yes Chair assigned Kevin from SSA as Adhoc Chair for Regional Service Slam. Assignment accepted. Now onto our area concerns...

- \$1000.00 donation to another region without areas' approval.... GPA would like explanation... (20 min)
- 2. June 2009 SEMA Convention SEMACNA 2 has scheduled their convention to be held the same weekend as Region.
 - a. After a lot of conversation...SEMA Rep asked us to re-schedule regional weekend so we could attend...after conversation we decided not to re-schedule.
- 3. Seek Regional Policy on Activities Calendar for our 11 Areas that make up the New England Region.
- 4. Our Convention took the majority of time allowed to discuss problems they are having...

First... Registrations are down 30% from previous Conventions (from outside our region)

Second... Our Registrations Computer that has the past

- i. Conventions attendance and addresses was stolen at NERC XII. We usually send individuals a convention flyer that have attended the past conventions
- ii. Note: NERC is an established convention with a great history. So to deal with this issue the Convention Information Chair has done a great job of making sure our surrounding Regions/Areas get their flyers in place... long before the Convention is to be held.

Third... as of 12/13/08 we have 12 Registrations.

Fourth...Our Regions 11 Areas have not registered as they have in the past. Please help by sending in your registrations if you plan on attending.

Fifth... Our Regional Convention as are other Conventions is dealing with a questionable economy... We have faith that it will all pan out in the end...but because of contracts signed...we as a fellowship need to be fiscally responsible that we hold up our contract obligations... The Room Block is 487... We are far from that with current reservations. (Cut off date is 2/20/08)

So the last is the biggest problem. Our NERC BOD Chair has to give the Hotel we are having NERC XIII

A check for \$15,000.00+ ... 2 days before NERC XIII all other monies are paid after the convention. We will more than likely meet all financial costs of NERC XIII. It's the up front money that we are short. Convention Treasury starting balance was \$7,566.25 the ending Balance was \$8,565.90 with a set aside \$1,665.00 The BOD has \$8,000.00 in their account. We are short...so the motion back to Areas is to suspend donations to WSO until after our NERC XIII is held.
