RCM Report: (Gail)

Much has gone on since the last Regional RSC. There were a few emergency Regional BOD and NERCC Corp. meetings held to determine if the Convention will go on in 2025 or not.

First Email received July 18th

The New England Regional Convention Corporation (NERCC) BOD has met 4 times since the June

RSC. Most of the discussion has focused on our current contract with the Sturbridge Host Hotel.

The

contract for NERC XX which is scheduled for March 2025 was signed in January of this year. The bid

process/hotel selection did not follow procedural requirements laid out in our policy/guidelines.

Upon

review of the signed contract in June, it was determined the contract is not fiscally viable. This is primarily due to a non-negotiable meeting space cost of \$28,750. Members of the NERCC met in person with the Sturbridge Host Hotel, requesting the hotel provide certain concessions to allow us to

- proceed with plans for the event. Despite our over 17-year history with the Sturbridge Host Hotel, they
- are under new management and have rejected all our attempts to re-negotiate a contract we are able to
- fulfill. The hotel did provide an offer that we can cancel the contract, but that requires forfeiting our
- \$5000 deposit which was paid earlier this year. If we do not accept this offer, the cancellation policy in
- the contract 6 months prior to the event will be subject to a penalty of approximately \$10,000.

 Review
- of the NERC XX budget and income generated at previous NERC conventions, suggests we would owe
- between \$11,000 and \$35,000 at the end of the convention. We would be unable to return the \$14,000
- seed money allocated for convention and corporation.
- As RCMs you are voting members of the New England Regional Convention Corporation. This is a
- decision which needs to include our RCMs, however it is imperative we make a decision as soon as
- possible to avoid further financial consequences. Due to the urgency of the matter and need for a vote.
- the BOD is calling an emergency corporation meeting to be held via Zoom Tuesday, July 23, 2024 at 7
- p.m. We will be sending a link shortly.
- I'm sure many of you will have similar questions, so please make a list of your questions and they will
- all be addressed at the meeting.
- Thank you for your service and understanding with the short notice for this meeting.

Hello RCMs/alternates.

- In follow-up to Tuesday night's meeting and the email sent last Thursday, there are several updates and
- clarifications. The check from Citizens has been received (\$10,001.23) and the signatories of the BOD
- and convention committee will be getting together in the near future to open a new bank account.
- those who attended Tuesday night's meeting, you know the registration income calculations I presented
- were low since they did not reflect the registration cost of \$35 set for general registration. I have recalculated the projected income which improves our chance of showing a profit at the end of the
- event. I have attached a spreadsheet with the initial and the most recent calculations included.

Presenting only these 2 scenarios simplifies things and reflects where we are now with the negotiations.

The convention committee is also reviewing the budget for areas there can be additional savings.

I sent out an email to the BOD and the NERC XX subcommittee members Wednesday asking if they

recommend continuing with NERC XX at the Sturbridge Host Hotel in March 2025 or if we should cancel and forfeit the \$5000 deposit. The results are: three of four BOD members recommend going

forward with NERC XX as planned for March 2025. The other BOD member did not respond. Seven

of nine convention committee members recommend moving forward. Two believe we should cancel

the convention and forfeit the \$5000 deposit. In full disclosure, 2 of the BOD members are also convention committee members.

Please respond to this email by Monday, July 29, 2024, with one of the following:

- 1. Move forward with NERC XX as planned for March 2025 at the Sturbridge Host Hotel.
- 2. Cancel the convention and forfeit the \$5000 deposit.
- 3. Abstain from vote.

I realize this is short notice however we need to provide an answer to the Hotel ASAP. Delaying a response and canceling at a later date would result in penalties of approximately \$10000. Please let me

know if you have any questions.

No Report

Activities Report (Lizzy)

The Activities Committee met 7/28 with 6 people in attendance.

We had a very disappointing turnout for the "NA Summer Olympics" which we equated possibly to the scheduling being the same day as June ASC as well as the 102-degree weather with 90% humidity the day of. We did manage to raise \$137.35 in addition to the \$22.65 of left-over seed money, so \$160 was given back to the ASC on 7/28. We still have all of the supplies for the field day games that were ordered using the initial seed monies, so we are looking at doing a potential "do-over" sometime in early October when the weather is much cooler.

We are still in discussion about holding a "5¢ Beach Party" sometime in August or possibly early September, weather permitting. The premise of the "5¢" part would be that our "entry fee" would be at least 1 empty redeemable beverage container (i.e. cans or bottles). All containers will be placed in a collection that would then be recycled, & the proceeds would be given back to the ASC. There is no limit to how many containers you may bring, but please make sure they are empty & redeemable.

Redeemable containers would be glass, plastic, metal, aluminum, and bi-metal containers holding carbonated soft drinks or mineral waters.

Non Redeemable containers would be dairy products, natural fruit juices, non-carbonated drinks, and containers holding more than two gallons of liquid.

Our next large event that we have started discussion about is holding an NA prom. There are so many addicts in recovery that dropped out of school & never got to experience a prom as well as those who just want to get dressed up & dance! We are looking to hold this event potentially at the end of January, but official details have not yet been decided. This would likely be a ticketed event as we are looking to have a true sit-down dinner prom, but no decisions have been finalized. Should this end up being a ticketed event, we will release the information as soon as possible in order to give as many people the opportunity to participate as possible.

We have decided to postpone Coffee Hours for the temporary future due to lack of participation, but hope to bring them back in the future.

During our 7/28 committee meeting we were joined by Kevin P. from the South-Side Unity Day Picnic, to discuss their participation as an official Ad-Hoc of the Activities Committee. He explained to us that there

have been some substantial changes for the event made by the RI Parks Association. These changes include:

- -No more than 150 present at a time (regular counts will be made during the event)
- -No more than 90 vehicles (so please carpool if possible)
- -Must having Parking Attendees
- -Amplified music must not disturb other park users (so the committee has forgone a DJ this year & will instead be using a boom-box controlled by the committee)
- -Must have identifiable "security" to contain the crowd (Committee members will be wearing badges during the event)
- -Must have insurance (the committee has gotten with the ASC to procure this)
- -An additional \$200 park fee

It is important to point out that these additional measures have been put in place due to the activity that has happened at past events for the South-Side Unity Day Picnic & the lack of respect shown to the public park & its workers. It would serve everyone well to remember that when we are at these events, we are representatives of Narcotics Anonymous as a whole & our behavior is a direct reflection. Because of past unfavorable behavior at NA events at this park, Narcotics Anonymous has now been flagged by the RI Parks & Rec, meaning it will be likely that additional regulations will be continued in the future for all NA events that take place at public parks in RI that are managed by the RI Parks & Rec Association.
